

OFFICIAL CALL  
Mass Meeting of the Harrisonburg Republican City Committee  
of the Republican Party of Virginia

As Chairman of the Harrisonburg Republican City Committee of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Greg L. Coffman, do hereby issue this call for a Mass Meeting to be held at Cecil Gilkerson Activities Center at 305 South Dogwood Avenue in Harrisonburg, Virginia starting at 6:30 PM local time on March 12, 2018, for the following purposes:

1. Electing a Chairman for the Harrisonburg Republican City Committee.
2. Electing the members of the Harrisonburg Republican City Committee.
3. Electing up to four hundred ninety-five (495) Delegates and an equal number of Alternates with a total voting strength of ninety-nine (99) votes to the Sixth Congressional District Committee Convention of the Republican Party of Virginia to be held on Saturday, May 19, 2018, at the James Madison University Convocation Center, 895 University Boulevard, Harrisonburg, Virginia 22807, or its alternate site, beginning at 10:00 a.m. local time for the following purposes:
  - a) Nominating a Republican candidate for the United States House of Representatives
  - b) Electing a Chairman for the Sixth Congressional District of the Republican Party of Virginia
  - c) Electing three (3) Regional Vice chairmen for the Sixth Congressional District of the Republican Part of Virginia
4. And for the transaction of such other business as may properly come before the mass meeting.

Qualifications for Participation:

All legal and qualified voters of Harrisonburg City, under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts. In addition to the foregoing, to be in accord with the principles of the Republican Party, a person otherwise qualified hereunder shall not have participated in Virginia in the nomination process of a party other than the Republican Party in the last five years. A single exception to the above shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that he/she is in accord with the principles of the Republican Party and intends, at the time of the writing, to support the nominees of the Republican Party in the future. A voter that utilizes the foregoing exception, and thereafter participates in the nomination process of a Party other than the Republican Party, shall not have the benefit of the exception as identified in this paragraph thereafter.

In order to be eligible for election as a Delegate or Alternate Delegate to any convention, an individual must be registered to vote no later than the pre-filing deadline established by the Official Committee or, if pre-filing is not a requirement, no later than the date of election as a Delegate. A person who has made application for registration and meets all other requirements herein, but whose name does not appear on the local registration books solely because of the books having been closed in connection with a local election, will nevertheless be deemed a legal and qualified voter.

## Filing Requirements

### Delegates:

Candidates for election as Delegates (and Alternates) to the May 19th District Convention may notify the Chairman of the Committee of his or her intention by either pre-filing pursuant to the requirements stated herein, or by being present at the Mass Meeting and so stating his or her intention. Candidates who pre-file do not need to be present at the Mass Meeting to be elected as a delegate. Pre-filing forms can be sent by mail to Greg L. Coffman, Harrisonburg Republican City Committee, 66 Laurel Street, Harrisonburg, VA 22801 or hand delivered to Greg L. Coffman and must be received no later than 5:00 p.m. March 9, 2018. Postmarks will not govern.

### Chairman:

Candidates for election to the position of Chairman of the Harrisonburg Republican City Committee shall file a written statement of intent to Greg L. Coffman, Chairman, at 66 Laurel Street, Harrisonburg, VA 22801, or email a scan of a written statement of intent to [glcoffman@hotmail.com](mailto:glcoffman@hotmail.com) which must be **received** not later than 5:00 p.m. on March 9, 2018. Postmarks will not govern. There shall be no nominations from the floor for the office of Chair.

### Registration and Fees:

The doors will open for registration at 6:00 p.m. on March 12 with registration to begin at 6:30 p.m. Any participant in line at 6:30 p.m. shall be allowed to register for the mass meeting. There is a *voluntary* registration fee of \$20 to participate in the 6<sup>th</sup> District Convention.

In approving this Call, the Harrisonburg City Republican Committee waived the State Party Plan requirements to publish the Call in the appropriate newspaper of record.
